SAT & ACT FEE WAIVER REQUEST

High school students in the U.S. or U.S. territories who can't afford to pay test fees may be eligible for SAT/ACT fee waivers. Fee waivers can be used for the SAT and ACT. U.S. citizens living outside the U.S. may also qualify for a fee waiver. Students must be in 11th or 12th grade to use an SAT/ACT fee waiver. To be eligible, you must meet **at least one** of the requirements below:

- ☐ Enrollment in or eligible to participate in the Federal Free and Reduced Price Lunch program (FRPL).
- ☐ Annual family income falls within the Income Eligibility Guidelines that are based on the USDA Food and Nutrition Service and used by schools, institutions, and facilities participating in the National School Lunch Program.
